Having introduced illustrations in the last issue, I had hoped to include in this one a half-tone print of a delightful photograph of Thomas Pulvertoft, brassfounder of Cork, identified on page 26 of Issue 4 as MOIO and surely the "father" of the modern Pulvertaft family.

Unfortunately the contrast in the print which I forwarded to the blockmakers was not good enough for their process and I will have to have some work done on it before I can use it in these papers. However, as it is such an important portrait for the modern family, I still plan to use it; perhaps in the next issue. Meanwhile I have dedicated this edition to the Pulvertofts of Fosdyke in the 16th and 17th centuries as I searched the parish registers earlier in the year and the entries which I found complement a number of early Pulvertoft wills which I have had on file for many years.

The Pulvertofts of Fosdyke

A search of the Fosdyke parish registers was prompted partly because of references to the village in several early Pulvertoft wills and partly because the 1981 printout of the International Genealogical Index includes seven Pulvertoft baptisms and two marriages there, making it one of the parishes most densely populated by the family! (see p 47)

The first relevant will is that of Nicholas Pulvertoft of Algarkirk dated 1541 and proved in the Consistory Court of Lincoln in the same year. He bequeathes household goods, livestock, farm implements and crops to his wife Agnes and his children Isabell and John and appears to have been married twice as he describes several items which he leaves to his daughter as "that was her mothers".

He asks to be buried at Fosdyke. The scrap pedigree which can be drawn from the will is:



The next reference to Fosdyke is made in the will of John Pulvertoft of Algarkirk, yeoman dated 24 Oct. and proved 22 Nov. 1580 in the Consistory Court of Lincoln. Not only does he leave land, livestock, farm implements and household goods to his wife and three children but also to Thos. son of Nich. Pulvertoft. He names some of his land; "10 acres pastures... called Crabden End" and "vij roodes of land lying in a place called Countwade Feld in the parish of Algarkirk". He says that some of his land had been bought from Robert Pulvertoft of Iwerne Minster. (see p 53) Finally he leaves to his son Nicholas "a seal of silver weyinge 2s 6d being a seal of arms" He asks to be buried at Fosdyke. The scrap pedigree from this will is:



(To illustrate the type of document being described, a section of John's will is reproduced overleaf, the part chosen being both particularly clear and one which includes reference to his wife and his three living children.)

The third will is that of John Pulvertoft of Algarkirk, yeoman, already used as one of the sources for the article on the Pulvertofts of Algarkirk in Issue 2, In his will John says that his father Thomas was buried at Fosdyke and he asks to be buried there as well.

And so to the Fosdyke registers; the first one is a wonderful relic, sewn but without hard covers it is much battered by the years and stained by damp, but when the first page offered a Pulvertoft baptism - previously unrecorded - the start was promising! The first register has christenings from 1559 to 1655, marriages to 1673 and burials to 1694. The second register has only 18 parchment leaves with a mixture of christenings, marriages S burials, some duplicating Volume I, some late additions and the whole spanning the period 1656 to 1696. The third register is not held at the Archives and so the Bishops Transcripts were searched to extend the period to 1718. From the will of John Pulvertoft of Algarkirk

Although the registers do not start early enough to record the burial of Nicholas Pulvertoft in 1541, the early entries confirm John's will and allow the scrap pedigree on page 67 to be redrawn as:



Similarly John Pulvertoft's request to be buried at Fosdyke made in his will of 1624 (see p 10) can be seen to have been honoured and a number of additions can be made to the pedigree on pages 12 S 13; Elizabeth bap. 1605, Thomas bur. 1607 and William and Thomas bap. 1608 -'though they were not shown previously because they died in 1608 and 1614 respectively.

The register entries between 1643 & 1675 suggest:



which is sufficiently similar to the final part of the pedigree on page 12 to allow them to be assumed the same. The last four entries suggest a small scrap pedigree relating Thomas, Mary, William and Robert but exactly how they are connected with the earlier Pulvertofts is not yet clear.

Notes and Queries

A Pulvertaft Marriage Discovered

In Issue 2 of these papers a list was printed of the Pulvertaft marriages found in the General Register Office Index of Marriages between 1837 and 1975 which was thought to be comprehensive. It was a surprise therefore to find in the 1984 printout of the International Genealogical Index a marriage between Mary Pulvertaft and William Bryan at Shoreditch on 12 February 1839 which had not been included in the GRO summary.

The indexes at St Catherine's House have been reexamined and the omission is now understood as it is incorrectly listed there as "Mary Pulvert" and was not therefore recorded in the Pulvertoft: Pulvertaft search. A copy of the marriage certificate was bought and was found to describe the marriage between William Bryan, bachelor, grocer of East St., Shoreditch, son of Timothy Bryan, bootmaker; and Mary Pulvertaft, widow, dressmaker of East St., Shoreditch, daughter of James Stewart, carpenter.

Although there is no mention of Cork in the certificate and research in Ireland has not yet shown a marriage of Mary Stewart into the Pulvertaft family, the partnership "Bryan & Pulvertaft", already recorded in Issue 4 page 31, implies a connection between the two families and might suggest that Mary followed William to London after the death of her husband.
